### Join NVPN for Hill Day in March!

The National Violence Prevention Network (NVPN) invites you to participate in a public education campaign on **Tuesday, March 14, 2017** aimed at educating members of Congress about the public health utility of NVDRS. Held in collaboration with the Safe States Alliance, the event is intended to bring state NVDRS staff or their partner representatives to Washington, DC to meet with their elected officials to enhance awareness and understanding of the NVDRS program.



Participants will receive background materials and meet with congressional staff of their Representative and Senators. The event will officially start with a Monday evening staff briefing and conclude by 4:30pm on March 14. All travel and meeting-related costs will be reimbursed by NVPN.

Our aim is to have NVDRS representatives meet with the offices of their elected officials to discuss the work you do with the NVDRS program. There will be no direct advocacy or request for federal funding during these meetings. The goal is only to educate.

### NVDRS in 21st Century Cures Act

The *21st Century Cures* act included language encouraging the expansion and improvement of NVDRS. The following language can be found in **Section 9013 of the 21st Century Cures Bill:**

- Encourages the Director of the Centers for Disease Control and Prevention (CDC) to improve, particularly through the inclusion of other states, the existing National Violent Death Reporting System.

This is a strong signal of Republican support for NVDRS and provides some early momentum for NVPN to build on as we head into the FY2018 appropriations process.

### NVPN at Injury Prevention Alliance



Paul Bonta represented NVPN at the recent [Midwest Injury Prevention Alliance](#) conference where he discussed opportunities for state-based NVDRS staff to engage in policy and advocacy activities at the state and national levels.
